## Background

In 2016, African Ministers of Agriculture, Higher Education and Training, and Science, Technology and Innovation met in Cape Town, South Africa and reviewed the Continent's landscape in terms of Agriculture and the role universities can play especially in terms of the Comprehensive Africa Agriculture Development Programme (CAADP), which is Africa's policy framework for agricultural transformation, wealth creation, food security and nutrition, economic growth and prosperity for all. They also considered the role African universities should play towards achieving the Science, Technology and Innovation Strategy for Africa (STISA-2024), which is a strategy adopted by the African Heads of State and Government in June 2014 as a continental framework for accelerating Africa's transition to an innovation-led, knowledge-based economy within the overall framework of the AU Agenda 2063. They agreed that Member States should work together to address three issues:

1. Urgency to develop a regional initiative to strengthen the contribution of African universities to support agricultural transformation in the continent. They tasked the Regional Universities Forum for Capacity Building in Agriculture (RUFORUM) to develop a framework for the he regional initiative, reach out to the Member States and funders. This was the origin of the Strengthening Higher Agricultural Education in Africa (SHAEA) regional

- concept. In 2017 in Malawi the World Bank announced a commitment of funding the initiative to the tune of \$250m through the International Development Association (IDA) window, which is the part of the World Bank that helps the world's poorest countries.
- 2. Concerted efforts to strengthen Science, Technology and Innovation in the continent for which RUFORUM was tasked to develop an initiative and reach out to the Islamic Develop Bank (IsDB).
- 3. Urgency to escalate graduate training especially at Doctoral level to strengthen capacity of African universities for generation of knowledge and technology.

RUFORUM worked with different agencies, universities and Member States and developed a framework documents for implementation of the Ministerial Round Table meeting decisions in Cape Town, South Africa. These were then presented to the Ministerial Round Table meeting of 24<sup>th</sup> October 2018 in Nairobi, Kenya. The Ministers deliberated on them and agreed on the following:

- i. Endorsement of the RUFORUM Charter to provide a legal framework for operations of RUFORUM in the different Member States. The Endorsement to follow each Member State's procedures
- ii. Development of a framework programme for Building Africa's Science, Technology and Innovation Capacity for Economic Growth (BASTIC) initiative and that this be marketed to the Islamic Development Bank, African Development Bank and other agencies.
- iii. Development of a Framework support for strengthening staff capacities and increasing the pool of women scientists in African universities and research institutions. That these framework document be presented to the Member States for implementation at country and continental levels, and RUFORUM was tasked to reach out to funding agencies, especially the African Development Bank, for funding.
- iv. Endorsement of the SHAEA initiative and RUFORUM was tasked to pursue the issue with the World Bank

Accordingly, RUFORUM Secretariat has developed Regional Initiative to Strengthen Staff Capacity and Increase the Pool of Women Scientists in African Universities (RISSCAW), which is intended to create a critical mass of staff, increase the pool of women scientists, strengthen university-industry relations, and enhance research and development support.

RUFORUM was tasked to work with universities and other actors to develop a few regional/continental initiatives to be considered by Member States and funding agencies. Following this decision, RUFORUM in partnership with OCP Morocco, and Arab Organisation for Agricultural Development (AOAD), in collaboration with the Arab Bank for Economic Development in Africa (BADEA) convened a consultative forum to explore collaboration and possible funding arrangements to support implementation of some of these initiatives. The forum endorsed the proposed continental initiatives (5) and that some if not all of them will require endorsement by

Member States for participation and to engage in dialogue with development partners for possible funding arrangements.

Accordingly in consultation with Member States and development partners, RUFORUM and Ghana Government is convening the Ministerial Round Table to receive and review the proposed regional initiatives for their individual country participation. The Ministerial Round Table meeting will be held on 5<sup>th</sup> December 2019 at University of Cape Coast. To guide the Ministerial Round Table deliberations, a meeting has been arranged for Technical Experts representing the Ministries of Agriculture; Higher Education and Training; Finance; and Science, technology and innovation to review the documents and advise their respective Ministers and country delegates accordingly.

## Objectives of the Technocrats Round Table Dialogue

The main objective of the Technocrats Round Table Meeting is to review the progress in implementation of Ministerial Decisions of October 2016 and October 2018, and also receive update on progress in implementations of the tasks assigned to RUFORUM during the C10 Summit in Lilongwe, Malawi in November 2019.

Therefore, the specific objectives of the Joint Meeting of Permanent Secretaries Responsible for Agriculture, Education & Training, Science, Technology and Innovation are to:

- 1. Receive and review the relevant documents pertaining to the proposed continental initiatives developed in line with the Ministerial Meeting decisions in Cape Town (South Africa) and Nairobi (Kenya)
- 2. Receive and consider an update on implementations of the Tasks assigned to RUFORUM by C10
- 3. Agree on Key recommendations for actions to be presented to the Ministerial Round Table Policy Dialogue on 5<sup>th</sup> December 2019
- 4. Agree on the draft Ministerial Communique to be considered by the Ministerial meeting

#### Meeting approach

There will be two main sessions: The first one, is setting the scene, in which there will be a presentation from the RUFORUM Secretariat and two technical papers: One, on realizing Africa's unmet Science, Technology and Innovation priorities in the face of competitive knowledge and innovation led development; The other technical paper will be on building a critical mass of faculty to enhance Africa's diversity and competitiveness.. Session two will focus on progress updates whereby RUFORUM Secretariat will present the draft regional initiatives in line with the decisions of the previous Ministerial Meetings (October 2016 &2018). There will be discussions on the various presentations from which key issues and needed actions will be distilled for consideration by the Ministerial Round Table Meeting the next day (Thursday 5<sup>th</sup> December 2019).
