Developing and Implementing Good Campus Policies to Reduce Sexual Harassment and Sexual Violence

Background

A safe environment for learning is a basic to fostering academic excellence. It is, therefore, a central interest of every university administration to develop and implement effective policies that reduce sexual harassment and sexual violence. Good models exist at some African universities; others lack such policies. This side event is a follow-on to the three-day pan-African symposium "Promoting Policies to Reduce Sexual Harassment and Sexual Violence" hosted in Senegal in 2017 by USAID's Innovation for Agricultural Training and Education (InnovATE) USAID/Senegal's Education and Research in Agriculture (ERA) project. Twenty-eight educational institutions from ten African countries discussed good practice in policy development. The 2017 symposium connected experienced professionals with counterparts having little to no experience in the subject. This 2018 RUFORUM side session widens participation in this policy dialogue and moves on to the topic of implementation and services.

The African Centre of Excellence in Sustainable Agriculture and Agribusiness Management (CESAAM) at Egerton University partners with regional institutions of higher learning. CESAAM has an interest in social and environmental safeguards, including reducing sexual harassment or violence. For this reason, CESAAM is a co-host of this side-event.

Purpose of the Side Event

This side session convenes experienced professionals and administrators to share insights into good policy content and good policy development processes. It is a platform for discussing how these policies are implemented, challenges to providing services with limited resources, and measuring success in improving campus safety

Objectives of the side Event

Focusing on prevention and setting behavioural norms, this side event supports pan-African cooperation for adoption and effective implementation of good policies that improve campus safety. Experienced universities will provide models for other universities.

Venue and Participants

The event is a resource for university administrators having responsibility for ensuring safe learning environments. It is particularly appropriate for administrators having responsibility for student and faculty conduct. Administrators new to the subject will leave with insights on how to organize and manage processes leading to creating good policies. Experienced professionals and administrators will leave with ideas on how to translate policy into practice.

Expected Outputs

- Through consideration of presentations of case studies and research, the 2017 symposium recommendations will be critiqued, and refined.
- Implementation and service priorities will be recommended
- The event will mark a transition from the convening power of projects to the convening power of African institutions.
