**Concept Note** 

#### **Background**

The RUFORUM Board of Trustees and Annual General Meeting constitute the supreme policy decision-making organs of the RUFORUM Network. The Board comprises Vice-Chancellors of all member Universities and other stakeholders who represent the non-University Board members. Annually, the Board meets once to conduct its business and all Board Members facilitate their participation in such meetings. The Board makes resolutions that are presented to the Annual General Meeting for ratification. The 21<sup>st</sup> RUFORUM Board Meeting is scheduled to take place on 15<sup>th</sup> December, 2022 as a blended event at Harare International Conference Centre, Zimbabwe. Subsequent to the last Board meeting held at Blue Auditorium, Palais des Congrès, Benin on 7<sup>th</sup> December, 2021 several new developments have transpired in the RUFORUM Network, warranting the need to have the Board updated on these new developments. The Board Executive Committee (BEC) also met once during the 2021/2022 period on behalf of the Board of Trustees to oversee Secretariat operations, and take decisions on behalf of the full Board as needed. The Board Executive Committee will report on actions taken on behalf of the Board.

### Purpose and objectives of the 21st RUFORUM Board Meeting

The 21<sup>st</sup> RUFORUM Board Meeting will conduct formal business and will among others, receive and consider the report of the Board Executive Committee. The meeting will further consider and make recommendations to the Annual General meeting, due to be held on 16<sup>th</sup> December, 2022 on the following key issues, among others:

- i. Consider minutes and actions from the 20th RUFORUM Board meeting;
- ii. Receive report from the Board Executive Committee on activities and actions on behalf of the Board since the December, 2021 Board Meeting in Cotonou, Benin;
- iii. Receive and consider Secretariat report for the Activity Year July 2021– June 2022 and proposed Annual Work plan and Budget for the Activity Year July 2022 June 2023;























- iv. Consider requests for membership from universities that wish to be part of the RUFORUM network; and,
- v. Review the 2021/2022 External Audit Report
