# Unpacking of Implementation of The Abidjan II Communique Action Plan: Practical Arrangements Towards the Roadmap for Implementation

## Background

The African Development Bank (AfDB), African Union Commission (AUC), One CGIAR, Forum for Agricultural Research in Africa and the Sub-Regional Research Organisations (SROs)<sup>1</sup>, African Forum for Agricultural Advisory Services (AFAAS), the Regional Universities Forum for Capacity Building in Agriculture (RUFORUM) and other African Agricultural Research and Innovation Institutions (AARIIs) participated in a series of high-level consultations between March and May 2022 which culminated in the commitments outlined in Abidjan II communique. The consultations were organized under "High-Level Consultative Forum on Strengthening Africa's Agricultural Research and Innovation in the Context of the One CGIAR Reforms". It aimed to embed clear mechanisms for ensuring mutual benefit for African institutions and their people into the programming, functioning, and governance of the One CGIAR.

The Action Plan resulting from the Abidjan II Communique contains Eight Action Areas listed in Table 1 and specifies the tasks involved, the responsible partners, expected outcomes, and timelines for the implementation.

The activities of the Action Plan are scheduled to start at the end of 2023 and early 2024 and are expected to be implemented over three years. The first planning meeting with implementing partners will be held on 1<sup>st</sup> November 2023 as a side event during the RUFORUM's 19<sup>th</sup> Annual General Meeting in Yaoundé, Cameroon. The planning meeting is organized to engage the proposed implementing partners to co-develop the initial practical arrangements for the implementation of the Action Plan. It is organized as a co-creation event as enshrined in the guiding principles of the Action Plan for the Abidjan II communique. The planning event rightly fits within the theme of RUFORUM's AGM of *"Transforming Higher Education to Sustainably Feed and Create Prosperity for Africa."*

## **Objectives of the Planning Meeting**

The main objective of the event is to popularise the Action Plan and agree on practical arrangements for the implementation roadmap.

The specific objectives are:

- a) Familiarise stakeholders with the background to, objectives of, action areas, and expected outcomes of the Abidjan II Communique and the Action Plan to operationalize it, and
- b) Develop a preliminary document describing the practical arrangements among the convening institutions with a clear segregation of roles and responsibilities for implementing the different activities outlined in the Action Plan with key milestones and institutions required.

### Side event approach

The rationale and events that precede the signing of the Abidjan II Communique will be presented by the One CGIAR. The key actors/convenors will also briefly present their initial thoughts on partners, roles, and relevant ongoing, pipeline, and new initiatives expected to contribute to the implementation of the Action Plan. In response to the information and issues raised in these presentations, a panel discussion will be held by representatives from the African Development Bank (AfDB), African Union Commission (AUC), One CGIAR, FARA, ASARECA, CORAF, CCARDESA, African Forum for Agricultural Advisory Services (AFAAS), and RUFORUM will be held. The purpose of the panel is to





provide a refreshed perspective on what these organizations see as their role as key actors in the implementation of the Action Plan and expected outcomes. Thereafter, a guided discussion with the audience will be held to review the Action Plan, the proposed areas, and responsible organizations to develop a road map for implementing the action areas and the tasks. The key activity here is to explain the expected outcomes, action areas, and elaborate in detail, the tasks to be undertaken. All these will be used to develop the institutional Practical Arrangements document to lead to the preparation of the Roadmap for the implementation of the Action Plan to operationalize the Abidjan II Communique.

### **Participants**

Heads or representations of AUC, AfDB, One CGIAR, FARA, ASARECA, CORAF, CCARDESA, AFAAS, and RUFORUM as key implementing partners of the Action Plan will be present. Senior government experts, development partners, research organizations, and university leaders at the level of Vice Chancellors, Principals, and Deans will be present. Approximately 100 participants are expected to attend this side event.

### Expected outputs and outcomes of the side event

The following outcomes are anticipated to be achieved.

- a) All partners become well acquainted with the background to, objectives of, action areas, expected outcomes, and their role in operationalizing the Abidjan II Communique, and
- b) A preliminary document describing the practical arrangements among the convening institutions with a clear segregation of roles and responsibilities for implementing the different activities outlined in the Action Plan.
