BACKGROUND

The need to invest in human capital is essential to support transition to a knowledge-based economies. Indeed country, <u>continental</u>, <u>global agencies</u> and forums such as the World Economic Forum all underscore the importance of skilling Africa's young people for the emerging world of work. According to the <u>United Nations Populations Fund</u>, 60 % of Africa's population is below 25 years, and is projected to reach 1.4 billion by 2063. Many of these youth are not being integrated into the cash economy. <u>The African Development Bank</u> estimates that 12 million young Africans are ready to enter the world of work annually, but the continent can only create one third of the required formal jobs. The recently launched <u>African Union Second 10-Year Implementation Plan of Agenda 2063</u>, also dubbed as the decade of acceleration (2024-2033), highlights the need for the continent to train at least 100,000 PhD level scientist over a decade.

The under-performing job creation nature of Africa's economy, the large demand for highly skilled personnel, the limited funding for higher and tertiary education, and the pressure on institutions of higher learning to expand admission for millions of young Africans graduating from secondary education has created immense pressure of Africa's Higher Education Sector. Yet Africa still has one of the lowest enrollments in higher education at 6%, just one quarter of the world average. The era of the structural adjustment programmes in Africa (1980-1990's), and the conversion of many tertiary education institutions into universities across Africa, has contributed to misbalancing of Africa's human resource pyramid. Africa must rebalance its skills sets in order to meet the diverse capacity needs of the continent. The central role of higher education in development is also underscored by the European Union's agenda for higher education. As such, some of the European Union's focus investments including Erasmus+, Horizon Europe, and other mechanisms, enable the higher education sector to adapt to new development demands and realities. Of concern is the need for green transitions and digital economy transitions compliant skilling and development solution. Europe and Africa share a lot in common including their socioeconomic development trajectories. Recent global threats, opportunities, and emerging futures call for concerted engagements to chart a shared vision of success.



















PURPOSE OF THE DIALOGUE

To leverage the convening power of both RUFORUM and Agrinatura¹ and their partners to engage and co-create policy directions for transformative African and European higher education, research, and innovation agendas.

OBJECTIVES

- 1. Hold high-level policy discussions that will set policy, research and innovation agendas and leverage existing frameworks for African and European Universities and allied institutions to support informed policy development and execution in Africa-Europe partnership.
- 2. Review, dialogue, and make recommendations for strengthening Africa-Europe in higher education, science, technology, and innovation.
- 3. Review, dialogue, and make recommendations for resourcing the implementation of actions that underpin green, digital, and inclusive Africa-Europe partnership in higher education, science, technology, and innovation.

APPROACH

The meeting is designed to have three sessions that will include an official opening, and two technical sessions that will focus on; (a) Policy frameworks for strengthening Africa-Europe Research and Science capacity; (b) Dialogues on experiences and lessons learnt from implementing intra-Africa, Africa-European partnerships as well as global collaboration for building human and science capacity for Africa. A mix of plenary presentations including presentation of keynote papers and panel discussions will be held. Statements will be made by the European Union, African Union Commission, and Governments. Representatives of apex higher education, and agricultural research bodies and development banks may make statements on accelerating investments in agricultural higher education and agricultural development.

EXPECTED OUTPUTS

- 1. Opportunities for strengthening co-creation of science and knowledge products to inform policy at country and continental levels identified and the leaders to champion development into concrete actions identified and endorsed.
- 2. An action plan and road map for engaging all stakeholders towards marshalling resources and investments for contemporary development focused higher agricultural education, science, technology and innovation within the framework of Africa-European collaborations developed.
