**Re: ISSUANCE OF VISAS TO UGANDAN PASSPORT HOLDERS TRAVELLING TO NAMIBIA**

The Government of the Republic of Namibia has introduced a Policy that will enable Ugandan Passport holders to be granted Visas at the point of entry.

The purpose of this letter is to draw your attention to the above Policy so that your clientele that falls under the above category is not inconvenienced. Also forwarded, for your information, is a list of other countries that benefit from this Policy.

However, please note that this Policy does NOT apply to the following categories: -

- Those looking for Employment or Pay related jobs (Employment/Work Permit or Work Visa is required).
- Prohibited Immigrants.
- Those on Watch Lists.
